On 6 September 2010, a supplemental agreement (“Supplemental Agreement”) was entered into between the Company and Jadehero Limited (“Jadehero”) to supplement the subscription agreement (the “Subscription Agreement”) dated 22 May 2009 between the Company (as issuer) and Jadehero (as subscriber). Pursuant to the Subscription Agreement, among others, an option (“Option”) was granted to Jadehero to further subscribe for the zero coupon convertible bonds in a maximum principal amount of HK\$128 million (“Optional Bonds”), which may be converted into a maximum of 800 million new shares of the Company with the conversion price of HK\$0.16 per conversion share. The Option is exercisable within a period of 12 months from 7 September 2009 to 6 September 2010 (“Option Period”). Pursuant to the Supplemental Agreement approved by the shareholders of the Company at an extraordinary general meeting of the Company held on 25 October 2010, the Option Period has been extended for a further 12 months and will expire on 6 September 2011	Nil	800,000,000
