**SUMMARY OF ELECTRICITY GENERATION VOLUME
OF SOLAR POWER PLANTS FOR THE FIRST QUARTER OF 2018**

This announcement is made by Kong Sun Holdings Limited (the “**Company**”, collectively with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest business development of the Group. The board of directors (the “**Directors**”) of the Company (the “**Board**”) announces that, according to the Company’s preliminary operating statistics currently available, the solar power plants owned by the Group have generated electricity in an aggregate volume of approximately 481,221 megawatt-hour (“**MWh**”) in the first quarter of 2018, representing a substantial increase of approximately 86% as compared to approximately 259,306 MWh for the corresponding period last year. The total installed capacity of the Group has reached 1,819.3 megawatts as at 31 March 2018.

Set forth below further breakdown of the electricity generated by the solar power plants owned by the Group (by geographical locations).
