Reference is made to the circular (the “Circular”) and the notice (the “Notice”) of the Annual General Meeting (the “AGM”) of Luks Group (Vietnam Holdings) Company Limited (the “Company”) dated 29 March 2012. None of these 511,931,418 shares entitling the holder to attend and vote only against the resolutions at the AGM.
