ANNOUNCEMENT ON KEY OPERATING DATA OF JUNE 2026

The enclosed announcement (the “**SSE Announcement**”) was published by Air China Limited (“**Air China**”) on the Shanghai Stock Exchange on 14 July 2026, which contains combined operating data for June 2026 for Air China and its subsidiaries (collectively, the “**Group**”). This announcement enclosing the SSE Announcement is made by Air China pursuant to Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

SSE ANNOUNCEMENT

The SSE Announcement is written in Chinese, with no official English translation. The English translation is provided solely for reference only. In case of any discrepancy between the two versions, the Chinese version shall prevail. The full version of the SSE Announcement is as follows:

AIR CHINA LIMITED ANNOUNCEMENT ON KEY OPERATING DATA OF JUNE 2026

In June 2026, Air China Limited (the “**Company**”) and its subsidiaries (the “**Group**”) recorded a year-on-year decrease in both combined passenger capacity (measured by available seat kilometers (the “**ASK**”)) and passenger traffic (measured by revenue passenger kilometers (the “**RPK**”)). Passenger capacity recorded a year-on-year decrease of 6.1%, and passenger traffic recorded a year-on-year decrease of 2.9%. Among which, for domestic routes, passenger capacity decreased by 7.7% year on year, and passenger traffic decreased by 6.7% year on year. For international routes, passenger capacity decreased by 1.6% year on year, and passenger traffic increased by 7.4% year on year. For regional routes, passenger capacity decreased by 16.4% year on year, and passenger traffic decreased by 11.5% year on year. The passenger load factor was 83.9%, representing an increase of 2.8 percentage points as compared to the same period last year. Among which, the passenger load factor for domestic routes increased by 0.9 percentage points year on year, the passenger load factor for international routes increased by 7.0 percentage points year on year, and the passenger load factor for regional routes increased by 4.4 percentage points year on year.

In terms of cargo operations, cargo capacity (measured by available freight tonne kilometers (the “**AFTK**”)) decreased by 6.3% year on year. Cargo and mail traffic (measured by revenue freight tonne kilometers (the “**RFTK**”)) decreased by 1.6% year on year. The cargo load factor was 48.0%, representing a year-on-year increase of 2.3 percentage points.

With effect from 5 June 2026, the Company launched the new route Wenzhou – Jeju, with two flights per week. With effect from 15 June, the Company launched the new route Chengdu Tianfu – Yan’an, with four flights per week.

In June 2026, the Group introduced one A320 series aircraft and one B737 series aircraft, and retired one A320 series aircraft. At the end of June 2026, the Group operated a fleet of 972 aircraft, including 427 self-owned aircraft, 260 aircraft under finance lease and 285 aircraft under operating lease.
