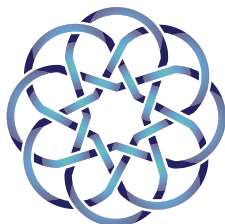

The Board is pleased to announce that the change of name of the English name of the Company from “O Luxe Holdings Limited” to “WE Solutions Limited” and adoption of the Chinese name “力世紀有限公司” as the dual foreign name of the Company to replace the Chinese name “奧立仕控股有限公司” have become effective on 28 February 2018.

Trading of the shares of the Company on the Stock Exchange under the stock short name “O LUXE HOLD” in English and “奧立仕控股” in Chinese will be changed to “WE SOLUTIONS” in English and “力世紀” in Chinese with effect from 9:00 a.m. on 10 April 2018. The stock code of the Company remains as “860”.

Reference is made to the announcement of WE Solutions Limited (formerly known as O Luxe Holdings Limited) (the “**Company**”) dated 12 January 2018 and the circular of the Company dated 26 January 2018 (the “**Circular**”) in relation to, among other things, the Change of Company Name. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise defined.

## **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the change of the English name of the Company from “O Luxe Holdings Limited” to “WE Solutions Limited” and adoption of the Chinese name “力世紀有限公司” as the dual foreign name of the Company to replace the Chinese name “奧立仕控股有限公司” have become effective on 28 February 2018. Following the passing of the special resolution for the Change of Company Name at the Annual General Meeting held on 28 February 2018, a Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 28 February 2018 and a Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 28 March 2018.

## **CHANGE OF STOCK SHORT NAME**

Trading of the shares of the Company on the Stock Exchange under the stock short name “O LUXE HOLD” in English and “奧立仕控股” in Chinese will be changed to “WE SOLUTIONS” in English and “力世紀” in Chinese with effect from 9:00 a.m. on 10 April 2018. The stock code of the Company remains as “860”.
