ANNOUNCEMENT ON VOTING RESULTS OF ANNUAL GENERAL MEETING HELD ON 23 APRIL 2026

At the annual general meeting of China Medical System Holdings Limited (the “**Company**”) held on 23 April 2026 (the “**AGM**”), all the proposed resolutions as set out in the notice of the AGM dated 1 April 2026 were duly passed by way of poll.

As stated in the circular of the AGM dated 1 April 2026 (the “**Circular**”), the total number of issued shares of the Company on the latest practicable date of the Circular was 2,439,528,512. In relation to all the resolutions proposed at the AGM, the total number of shares of the Company entitling the holders to attend and vote for or against the resolutions at the AGM was 2,439,528,512. There is no restriction on any shareholder casting votes on any of the resolutions at the AGM. There were no shares of the Company entitling the shareholders to attend and abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholder was required to abstain from voting on any of the resolutions proposed at the AGM under the Listing Rules. No person has indicated in the Circular that it/he/she intends to vote against or to abstain from voting on any of the resolutions proposed at the AGM.

The Company’s branch share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the AGM.

All the directors of the Company attended the AGM either in person or electronically.
