3. Any Scheme Shareholder entitled to attend and vote at the Court Meeting is entitled to appoint another person as his proxy to attend and vote instead of him. If any proxy other than the Chairman of the Court Meeting is preferred, strike out the words “THE CHAIRMAN OF THE COURT MEETING or” and insert the name and address of the proxy desired in the space provided. A Scheme Shareholder who is the holder of two or more Scheme Shares may appoint more than one proxy to attend and vote on his behalf at the Court Meeting provided that if more than one proxy is so appointed, the appointment shall specify the number and class of shares in respect of which each such proxy is so appointed. **IF NO NAME IS INSERTED, THE CHAIRMAN OF THE COURT MEETING WILL ACT AS YOUR PROXY. ANY ALTERATION MADE TO THIS PINK FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.**
4. **IMPORTANT: IF YOU WISH TO VOTE FOR THE SCHEME OF ARRANGEMENT, PLEASE (“✓”) TICK THE BOX MARKED “FOR”. IF YOU WISH TO VOTE AGAINST THE SCHEME OF ARRANGEMENT, PLEASE (“✓”) TICK THE BOX MARKED “AGAINST”.** You must vote all of your shares in the capital of the Company registered in your name either **FOR** the Scheme or **AGAINST** the Scheme. You cannot vote some shares **FOR** the Scheme and some shares **AGAINST** the Scheme. If more than one proxy form is submitted and the voting instructions require proxies to vote both **FOR** and **AGAINST** the Scheme, the proxy forms will not be accepted. If more than one proxy form is submitted and the voting instructions require proxies to vote either **FOR** or **AGAINST** the Scheme but not **FOR** and **AGAINST** the Scheme, the Chairman shall have absolute discretion as to whether or not to accept the proxy forms. Failure to tick either box will entitle your proxy to cast his vote or abstain at his discretion. Your proxy will also be entitled to vote at his discretion on any resolution properly put to the Court Meeting other than those referred to in the Notice of the Court Meeting. Voting on the Scheme relates to the following resolution at the Court Meeting: “*THAT this Court Meeting approves, with or without modification, the proposed Scheme of Arrangement, and a print of which has been submitted to this Court Meeting and, for the purpose of identification, signed by the Chairman of this Court Meeting*”.
5. This pink form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of an officer or attorney or other person duly authorized to sign the same.
6. In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of votes of the other joint holder(s) and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company.
7. To be valid, this pink form of proxy together with the power of attorney (if any) or other authority (if any) under which it is signed or a certified copy thereof, must be completed, signed and deposited at the Hong Kong branch share registrar and transfer office of the Company, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong, as soon as possible and in any event not later than 9:00 a.m. on Sunday, October 15, 2017. If this pink form of proxy is not so deposited, it may, however, be handed to the Chairman of the Court Meeting at the Court Meeting, who shall have absolute discretion as to whether or not to accept it. Completion and delivery of this pink form of proxy will not preclude you from attending the Court Meeting (or any adjournment thereof) and voting in person at the Court Meeting (or any adjournment thereof) if you so wish, but in the event of your attending the Court Meeting after having lodged this pink form of proxy, this pink form of proxy will be deemed to have been revoked.
8. The proxy need not be a member of the Company but must attend the Court Meeting in person to represent you.
9. The full text of the Scheme of Arrangement and a copy of an explanatory memorandum explaining the effect of the Scheme of Arrangement appear in the composite scheme document dated September 22, 2017.
