This announcement is made by Future Land Development Holdings Limited (the “**Company**”) pursuant to the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 and Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Future Land Holdings Co., Ltd.* (新城控股集團股份有限公司) (“**Future Land Holdings**”) is a subsidiary of the Company with its A shares listed on the Shanghai Stock Exchange (the “**SSE**”) (stock code: 601155).

Pursuant to the Rules Governing the Listing of Bonds on the Shanghai Stock Exchange* (《上海證券交易所債券上市規則》) and Measures on the Offering and Trading of Corporate Bonds* (《公司債券發行與交易管理辦法》), Future Land Holdings published an announcement headlined “Announcement on the Accumulated New Borrowing of the Current Year* (關於當年累計新增借款的公告)” (the “**Announcement**”) on the website of the SSE on April 10, 2018 and a copy of the Announcement is available for download on the website of the SSE (www.sse.com.cn). It is disclosed in the Announcement that, the borrowing balances of Future Land Holdings as of March 31, 2018 were approximately RMB51.997 billion, representing an increase of RMB9.333 billion as compared to that by the end of 2017.
