CONTRACTED SALES

The board (the “**Board**”) of directors (the “**Directors**”) of Seazen Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that in September 2022, the Group achieved the contracted sales of approximately RMB8.328 billion, and the contracted sales area of approximately 941,100 sq.m..

Between January and September 2022, the aggregated contracted sales amounted to approximately RMB93.875 billion, and the aggregated sales area amounted to approximately 9,521,200 sq.m..

PROPERTY LEASES

In September 2022, the Group had a total of 134 properties for lease, with a total gross floor area of approximately 12,574,200 sq.m.. The rental income* for September 2022 amounted to approximately RMB0.806 billion, and commercial operating income** for September 2022 amounted to approximately RMB0.862 billion (i.e. tax-included rental income).

Between January and September 2022, the aggregated rental income* amounted to approximately RMB6.719 billion, and the aggregated commercial operating income** amounted to approximately RMB7.195 billion (i.e. tax-included rental income).

*: Rental income includes rentals, management fee, carpark, various operation and other sporadic management income.

** : Commercial operating income represents tax-included rental income.
