For details, please refer to the Company's announcements dated 13 September 2016 and 27 October 2016.

On 7 October 2016, the Company entered into the second convertible preference share transfer agreement with the second purchasers, pursuant to which the Company has conditionally agreed to procure the sale of and the second purchasers have agreed to purchase 100,000,000 convertible preference shares in aggregate at the transfer price of HK\$0.24 per convertible preference share. On 28 October 2016, the Company entered into the additional second convertible preference share transfer agreement with the second purchasers, pursuant to which the Company has conditionally agreed to procure the sale of and the second purchasers have agreed to purchase additional 136,665,238 convertible preference shares in aggregate at the transfer price of HK\$0.233 per convertible preference share.
