Whether a Shareholder is a Hong Kong or an overseas Shareholder will be determined by the address of that Shareholder appearing on the Register of Members of the Company maintained by the Company’s Hong Kong listed share registrar.

If you choose electronic means, we will send you an e-mail notification of the release of the relevant Corporate Communication(s) on the Company’s website on the day such Corporate Communication(s) is/are sent to Shareholders. Alternatively, if the electronic means is chosen, but you have not provided your e-mail address, printed Corporate Communications will be sent out in accordance with the arrangements described in the previous paragraph.

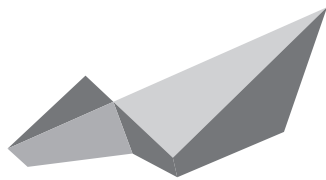
