On 18 August 2014, after trading hours of the Stock Exchange, the Company entered into the Subscription Agreements with (i) Thriving Market Limited; and (ii) Mr Hu Weijun (the “Subscribers”), pursuant to which, the Company has conditionally agreed to issue and the Subscribers have conditionally agreed to subscribe for 110,000,000 Warrants at the issue price of HK\$0.01 per Warrant. The Warrants will entitle the holders thereof to subscribe in cash up to an aggregate amount of HK\$212,300,000 (subject to adjustment) for the Warrants Shares and each Warrant carry right to subscribe for one Share at an initial Subscription Price of HK\$1.93 per Share, for a period of 60 months commencing from the date of issue of Warrants. Base on the initial Subscription Price of HK\$1.93 per Warrant Share, a maximum of 110,000,000 Warrant Shares will be allotted and issued by the Company.
