Completion and return of the proxy form will not preclude any member from attending and voting in person at the meeting or any adjourned meeting should he/she so wish.
 - Submission of this proxy form shall not preclude you from attending and voting in person at the meeting or any adjourned meeting should you so wish, and the appointment of the proxy will be revoked if you vote in person at the meeting.
