POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 20 JUNE 2025

Reference is made to the circular (the “**Circular**”) of Cirtek Holdings Limited (the “**Company**”) dated 28 April 2025 setting out, inter alia, the notice (the “**Notice**”) of the Company’s annual general meeting (the “**AGM**”) held on 20 June 2025. Terms used herein shall have the same meanings as defined in the Circular unless the context otherwise requires.

As at the date of the AGM, the Company has a total 2,000,000,000 issued Shares, among which 10,460,000 are treasury shares, and the total number of Shares entitling the Shareholders to attend and vote on the resolutions (the “**Resolution(s)**”) proposed at the AGM was 1,989,540,000. There was no restriction on any Shareholders casting votes on any of the proposed Resolutions at the AGM. There was no Share entitling the Shareholders to attend and abstain from voting in favour of the proposed Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting at the AGM. No Shareholder has stated his/her/its intention in the Circular to vote against or abstain from voting on any proposed Resolution at the AGM.

The Company has appointed Tricor Investor Services Limited, the Company’s branch share registrar in Hong Kong, to act as the scrutineer for the purpose of vote-taking at the AGM.
