**FURTHER DELAY IN DESPATCH OF CIRCULAR AND

Reference is made to the announcement of Jakota Capital (Holding) Group (the “**Company**”) dated 6 March 2026 in relation to, among others, (i) the proposed share consolidation and capital reduction of issued shares and sub-division; and (ii) the announcements of the Company dated 13 March 2026 and 27 March 2026 in relation to the delay in despatch of circular (collectively, the “**Announcements**”). FURTHER DELAY IN DESPATCH OF CIRCULAR

As disclosed in the Announcements, a circular (the “**Circular**”) containing, among other things, (i) a letter from the Board setting out further details about the Share Consolidation, the Capital Reduction, and the Share Sub-division; (ii) any other information required under the Listing Rules; and (iii) a notice convening the EGM, is expected to be despatched to the Shareholders on or before Friday, 17 April 2026.

As additional time is required for the Company to prepare and finalise the information to be contained in the Circular, it is expected that the despatch of the Circular will be postponed to a date falling on or before Friday, 8 May 2026.
