Remarks (if any):

1. On July 21, 2017, Strategic International Group Limited, a direct wholly-owned subsidiary of the Company issued the convertible bonds (the "Bonds") at the initial conversion price of HK\$14.28 per share in an aggregate principal amount of €300,000,000 subject to certain terms and conditions. The Bonds will be convertible into approximately 188,363,445 shares of the Company (assuming full conversion of the Bonds at the initial conversion price of HKD14.28 per share) and the conversion period shall commence on August 31, 2017. Details of the Bonds are set out in the announcements of the Company dated July 12, 2017 and July 21, 2017.

2. On April 16, 2020, the Company repurchased an aggregate principal amount of €5,000,000 in face value of the Bonds through over-the-counter market in accordance with the terms and conditions of the Bonds. Immediately after repurchase of the Bonds, the Bonds will be convertible into approximately 185,224,054 shares of the Company (assuming full conversion of the Bonds at the initial conversion price of HK\$14.28 per share). Please refer to the Company's announcement dated April 20, 2020 for details of the repurchase.
