PROFIT WARNING

This announcement is made by the China Tangshang Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) announces that based on a preliminary review of the latest unaudited consolidated management accounts of the Group and other information currently available to the Board, it is expected that the Group will record a loss of approximately HK\$48.0 million for the six months ended 30 September 2020, representing a significant increase as compared to the loss of approximately HK\$26.9 million recorded by the Group during the corresponding period in 2019, due to the fact that the revenue of the Group was adversely affected by the weak market sentiment of exhibition segment and sub-leasing business in Nanjing as a result of the impact of COVID-19 pandemic during the six months ended 30 September 2020. In addition to the influence of COVID-19 pandemic aforesaid, the Board also expected increase in loss for the six months ended 30 September 2020 mainly due to fair value loss on investment properties of approximately HK\$40.0 million in light of the application of HKFRS 16 Lease.

The Company is still in the process of finalising its interim results for the six months ended 30 September 2020. The contents contained in this announcement are only based on the information available to the Company and such information has not been audited or reviewed by the Company’s auditor or audit committee. Further details of the Group’s performance will be disclosed in its interim results for the six months ended 30 September 2020 to be published by the Company by the end of November 2020.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.
