POLL RESULTS OF ANNUAL GENERAL MEETING

Reference is made to the notice of annual general meeting (the “**Notice**”) of Yihai International Holding Ltd. (the “**Company**”) dated 27 April 2026. The annual general meeting (the “**AGM**”) of the Company was held at Meeting Room, 3rd Floor, Yihai International Holding Ltd. Building, 2300 Huxinan Road, Yushan District, Ma’anshan City, Anhui Province, PRC at 2:00 p.m. on Tuesday, 26 May 2026.

Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the circular of the Company dated 27 April 2026 (the “**Circular**”).

The AGM was conducted by way of voting by poll. As at the date of convening the AGM, the total number of the issued Shares and the Shares entitling the holders to attend and vote on any resolutions proposed at the AGM was 1,036,700,000 Shares. JLJH YIHAI Ltd, which is wholly owned by the trustee of the 2026 share award scheme of the Company as a holding platform, abstained from voting at the AGM with respect to 66,568,000 Shares held in accordance with Rule 17.05A of the Listing Rules. Shareholders or their proxies who represent a total of 681,296,203 voting Shares of the Company, representing approximately 65.72% of the total issued Shares of the Company as at the date of the AGM, attended the AGM. Computershare Hong Kong Investor Services Limited, the Hong Kong branch share registrar of the Company, was appointed by the Company as the scrutineer of the AGM.

To the best knowledge, information and belief of the Board after having made all reasonable enquiries, save as disclosed above, there was no Share entitling the Shareholders to attend and abstain from voting in favour of any of the proposed resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules and no Shareholder was required under the Listing Rules to abstain from voting on the proposed resolutions at the AGM. No party has stated his/her/its intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the AGM. All Directors attended the AGM in person or by means of electronic communication.

At the AGM, the following resolutions were considered and approved by way of poll by the Shareholders and their proxies, and the poll results are as follows:
