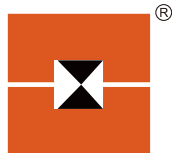

UNAUDITED OPERATING FIGURES FOR THE FIVE MONTHS ENDED 31 MAY 2020

This announcement is made by Kaisa Group Holdings Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) on a voluntary basis.

The board of directors (the “**Board**”) of the Company is pleased to announce the certain unaudited operating figures of the Group together with its joint ventures and associates for the five months ended 31 May 2020.

The Group together with its joint ventures and associates recorded contracted sales of approximately RMB9,052 million in May 2020, representing a year-on-year increase of approximately 24.4%. Contracted gross floor area (the “**GFA**”) in May 2020 amounted to approximately 603,256 sq.m. representing a year-on-year increase of approximately 59.8%. The average selling price (the “**ASP**”) for May 2020 was approximately RMB15,005 per sq.m., representing a year-on-year decrease of approximately 22.2%.

The total contracted sales of the Group for the five months ended 31 May 2020 amounted to approximately RMB27,061 million with the total contracted GFA of approximately 1,644,485 sq.m., representing a decrease of approximately 2.7% and an increase of approximately 14.2% as compared with corresponding period in 2019, respectively. The ASP for the five months ended 31 May 2020 amounted to approximately RMB16,456 per sq.m., representing a decrease of approximately 14.8% as compared with the corresponding period in 2019.

The preliminary figures disclosed above are unaudited and are based on preliminary internal information of the Group which are subject to change and, if required, necessary adjustments and may differ from those appear in the audited or unaudited consolidated financial statements of the Group to be published by the Company on yearly or half-yearly basis. They shall not be taken as a measure or indication of the Group's current or future operating or financial performance. As such, the above figures are provided for investors' reference only.
