POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 21 MAY 2026

The board (the "**Board**") of directors (the "**Directors**") of Hygieia Group Limited (the "**Company**") is pleased to announce that all the proposed resolutions as set out in the notice of the annual general meeting dated 28 April 2026 were duly passed by way of poll at the annual general meeting of the Company held on 21 May 2026 (the "**AGM**").

Tricor Investor Services Limited, the Hong Kong branch share registrar of the Company, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the Company did not hold any treasury Shares and the issued share capital of the Company comprised 2,000,000,000 ordinary shares of HK\$0.01 each (the "**Shares**"), which was the total number of Shares entitling the registered holders of the Shares (the "**Shareholders**") to attend and vote for or against all the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**"). No Shareholder was required under the Listing Rules to abstain from voting at the AGM. None of the Shareholders has stated their intention in the Company's circular dated 28 April 2026 to vote against or to abstain from voting on any of the resolutions proposed at the AGM.

As more than 50% of the votes were cast in favour of each of the ordinary resolutions, all of the ordinary resolutions were passed as ordinary resolutions of the Company.

All Directors attended the AGM.

The distribution of final dividend of 0.001 Singapore dollars ("S\$") per Share was approved at the AGM. The final dividend will be paid in Hong Kong dollars ("HK\$") and the actual amount to be paid is calculated at S\$1 = HK\$6.1715, being the exchange rate of S\$ against HK\$ published by The Hong Kong Association of Banks on 20 May 2026. Accordingly, the dividend to be paid per Share is HK\$0.0061715, which will be distributed on 17 June 2026 to Shareholders whose names appear on the register of members of the Company on 29 May 2026.
