References are made to the announcements of the Company dated 9 November 2017 and 30 November 2017 and the circular of the Company dated 22 December 2017 (the “**Circular**”) respectively in relation to the Disposal. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

**SUPPLEMENTAL AGREEMENT**

On 29 March 2018 (after trading hours), the Sellers and the Buyers entered into a supplemental agreement to the Disposal Agreement (the “**Supplemental Agreement**”), pursuant to which the Sellers and the Buyers have mutually agreed in writing to extend the long stop date of the Disposal Agreement to 30 April 2018 (or such other date as the Sellers and the Buyers may agree in writing), as additional time is required for the Company to fulfill the conditions precedent under the Disposal Agreement.

As at the date of this announcement, the Company is in the course of obtaining the documentation from the government authority in respect of transactions contemplated under the Disposal Agreement, all other conditions under the Disposal Agreement have been fulfilled. The Company expects that the completion will take place shortly after the fulfillment of all conditions.

Save as disclosed above, all other terms and conditions of the Disposal Agreement shall remain unchanged and continue in full force and effect in all respects.
