The Warrants carry subscription rights entitling its holders to subscribe for Warrant Shares at the initial Warrant Subscription Price of HK\$0.99 per Warrant Share (subject to adjustments). Pursuant to the provisions on adjustments to the Warrant Subscription Price set out in the terms and conditions of the Warrants, as a result of the declarations of dividend by the Company on 22 August 2017, 22 March 2018 and 28 March 2019, respectively, the Warrant Subscription Price was adjusted to HK\$0.761 per Warrant Share.
