POLL RESULTS OF THE ANNUAL GENERAL MEETING

The board (the “**Board**”) of directors (the “**Directors**”) of HPC Holdings Limited (the “**Company**”) is pleased to announce that, all the proposed ordinary resolutions (the “**Proposed Resolutions**”) as set out in the notice of the annual general meeting of the Company dated 9 March 2026 (the “**AGM Notice**”) were duly passed by the shareholders of the Company (the “**Shareholder(s)**”) by way of poll at the annual general meeting of the Company held on 30 April 2026 (the “**AGM**”).

As at the date of the AGM, the total number of issued shares of the Company (the “**Share(s)**”) was 1,600,000,000 Shares, which was the total number of Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any Proposed Resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No Shareholder was required to abstain from voting on any of the Proposed Resolutions at the AGM under the Listing Rules. No person has indicated in the circular of the Company dated 9 March 2026 (the “**Circular**”) that he/she/it intends to vote against or to abstain from voting on any of the Proposed Resolutions at the AGM.

The AGM was chaired by Mr. Shi Jianhua, an executive Director of the Company. Except Mr. Wang Yingde, the chairman of the Board and Ms. Chen Liping, all Directors attended the AGM.

Boardroom Share Registrars (HK) Limited, the Hong Kong branch share registrar of the Company, was appointed and acted as the scrutineer for the vote-taking at the AGM.
