COMPLETION OF ISSUANCE OF 2026 THIRD TRANCHE
OF ULTRA-SHORT-TERM DEBENTURES

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The Company completed the issuance of 2026 third tranche of the ultra-short-term debentures on 20 April 2026 (the “**Debentures**”). The total issuing amount of the Debentures was RMB2.0 billion, with a maturity period of 122 days (the maturity date being 21 August 2026). The nominal value was RMB100 and the interest rate was 1.38%. Interest was accrued from 21 April 2026.

Industrial Bank Co., Ltd. acted as the lead underwriter and bookrunner and Shanghai Pudong Development Bank Co., Ltd. and Beijing Rural Commercial Bank Co., Ltd. acted as the joint lead underwriters of the Debentures. The Debentures were publicly issued in the PRC inter-bank bond market through centralized book-building and centralized placing. The proceeds from the issue of the Debentures will be used to repay the borrowings of the Company and improve its financing structure.

The relevant documents relating to the issuance of the Debentures were published on the website of Shanghai Clearing House (<http://www.shclearing.com>).

The issuance of the Debentures did not constitute any transaction under Chapter 14 and Chapter 14A of the Listing Rules.

This announcement does not constitute, or form part of, an offer or invitation, or solicitation or inducement of an offer, to subscribe for or purchase any of the debentures or other securities of the Company, nor is this announcement calculated to invite offers for any securities of the Company.
