10. *"Identical" means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

Remarks: The total number of issued shares as at 28 February 2022 was 25,010,534,995 (comprising 4,633,068,569 Class A ordinary shares and 20,377,466,426 Class B ordinary shares).

Xiaomi Corporation (the "Company") purchased a total of 34,509,400 class B ordinary shares during the period from 26 November 2021 to 19 January 2022 (the "Shares Repurchased") on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 11 March 2022 and the number of class B ordinary shares in issue was reduced by 34,509,400 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighted voting rights ("WVR") beneficiaries of the Company, simultaneously reduced their WVR in the Company proportionately by way of converting their class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
