## **VOLUNTARY ANNOUNCEMENT LICENCE AGREEMENT**

The board (the “**Board**”) of directors (the “**Director(s)**”) of eprint Group Limited (the “**Company**”) is pleased to announce that on 21 December 2017, Da Jin Lai Technology (Shenzhen) Company Limited\* (大金來科技(深圳)有限公司), a wholly-owned subsidiary of the Company, (the “**Licensor**”) and Protoss It Sdn Bhd (the “**Licensee**”) entered into the licence Agreement (the “**Licence Agreement**”), pursuant to which the Licensor agreed to grant to the Licensee the rights (“**Rights**”) to use the Software (as defined below) by the Licensee paying to the Licensor the aggregate licence fee of Malaysian Ringgit 2,550,000 for the Rights.

The Software include:

1. Da Jin Lai printing management system software (V1.0) (大金來印刷管理系統軟體 (V1.0))
2. Da Jin Lai e-print mobile application software (V2.07) (大金來e-print移動應用軟體 (V2.0))
3. Da Jin Lai e-print platform (大金來e-print網站)
4. Da Jin Lai e-print self-service platform (大金來e-print自助平台)

To the best of the Directors’ knowledge, information and belief, having made all reasonable enquiries, the Licensee and its ultimate beneficial owners are independent of the Company and connected persons (as defined in the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited) of the Company.

The term of the Licence Agreement shall commence from the date of signing of the Licence Agreement until the expiration of protection period of the copyright of the Software.

The Licensee is a company incorporated in Malaysia and an indirectly 30% owned associate of the Company. It is principally engaged in the information technology business.

The principal business of the Group is the provision of printing services and solutions on advertisement, bound books and stationeries, to a diversified customer base in Hong Kong.

The Directors believe that the entering into the Licence Agreement could help to promote the popularity of the Software in Malaysia as well as to be an effective way to expand the Group's business in Malaysia and hence improve the return to the Company and its shareholders.
