ANNOUNCEMENT

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

The board of directors of SIM Technology Group Limited (“**Company**”, together with its subsidiaries, “**Group**”) hereby announces that the unaudited monthly revenue of the Group for the month of May 2018 is approximately HK\$164.0 million (April 2018: HK\$285.9 million), in which the revenue from the sale of residential properties and properties management (together, “**non-core business**”) is approximately HK\$20.9 million (April 2018: HK\$ 25.5 million) and the revenue from the handsets and internet of things terminals business, the wireless communication modules business, the internet of things system and online-to-offline business together with the intelligent manufacturing business (together, “**core business**”) is approximately of HK\$143.1 million (April 2018: HK\$260.4 million). The revenue of the core business of May 2018 decreased by 45.0% as compared with that of last month, and decreased by 43.9% as compared with that of the same period last year (May 2017: HK\$255.3 million). The unaudited revenue of the Group for the five months ended 31 May 2018 is approximately HK\$1,156.6 million, which increased by 1.6% as compared to same period last year (five months ended 31 May 2017: HK\$1,137.8 million).

The Group is principally engaged in the People's Republic of China in (i) the ODM (original design manufacturer) of handsets and intelligent terminals, (ii) the provision of EMS (electronic manufacturing services) in wireless communication modules business, (iii) the intelligent manufacturing business, (iv) the internet of things business, (v) property development in a small scale, and (vi) property rental management business.

The above information is extracted from the management accounts of the Group, which have not been reviewed or audited by the auditors of the Company. All information shall be subject to the audited financial information of the Group. Investors and shareholders of the Company are advised not to rely on such information, and the directors of the Company shall not be responsible for any reliance placed thereon.
