**SUZHOU AND JIANGYIN**

The board of directors (the “**Board**”) of Honworld Group Limited (the “**Company**”) is pleased to announce that the Company concluded contracts with Suzhou Sangang Agricultural and Sideline Products Distribution Co., Ltd (蘇州三港農副產品配送有限公司) (“**Suzhou Sangang**”), Jiangsu Junrui Food Distribution Co., Ltd (江蘇駿瑞食品配送有限公司) (“**Jiangsu Junrui**”) and Suzhou Jianglan Agricultural Science & Technology Development Co., Ltd (蘇州江瀾生態農業科技發展有限公司) (“**Suzhou Jianglan**”), independent third parties of the Company, respectively in early September 2015 to make cooperation on supplying seasonings to the school canteens of different areas.
