CHANGE OF COMPANY NAME, STOCK SHORT NAMES, COMPANY LOGO AND COMPANY WEBSITE

Reference is made to (a) the announcement of the Company dated 23 October 2025, and (b) the circular (the “**Circular**”) of the Company dated 5 November 2025, in relation to the second proposed change of the Company’s name (the “**Second Change of Company Name**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

As stated in the Circular, the change of the English name of the Company from “China Financial Leasing Group Limited” to “Long Corp” and the adoption of the Chinese name “Long 集團” as its new dual foreign name to replace its then Chinese business name “中國金融租賃集團有限公司”, has been approved by the Shareholders at the September EGM and became effective on 22 September 2025 when the Certificate of Incorporation on Change of Name was issued by the Cayman Registrar. Subsequently, it is proposed to change the English name of the Company from “Long Corp” to “Long Investment Corp” and adopt the Chinese name “Long 投資集團” as its new dual foreign name to replace its existing Chinese name “Long 集團”.

The Board is pleased to announce that the proposed change of the English name of the Company from “Long Corp” to “Long Investment Corp” and adoption of the Chinese name “Long 投資集團” as its new dual foreign name to replace its existing Chinese name “Long 集團” became effective on 28 November 2025 when the Certificate of Incorporation on Change of Name was issued by the Cayman Registrar. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 December 2025, confirming the registration of the new names of the Company in Hong Kong under Part XVI of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAMES

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “CH FIN LEASING” to “LONG INV CORP” in English and from “中國金融租賃” to “LONG 投資集團” in Chinese with effect from 9:00 a.m. on 24 December 2025. The stock code of the Company on the Stock Exchange remains unchanged as “2312”.

EFFECTS OF CHANGE OF COMPANY NAME AND STOCK SHORT NAMES

The Second Change of Company Name and the change of the stock short names of the Company will not affect any rights of the Shareholders or the Company’s daily business operation and its financial position.

All existing share certificates in issue bearing the former name of the Company will continue to be evidence of title to such securities and the existing share certificates will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of the existing share certificates of the Company. With effect from 24 December 2025, new share certificates will be issued in the new name of the Company.

CHANGE OF COMPANY LOGO

The Company has adopted a new logo as shown on the top of this announcement to reflect the Second Change of Company Name with effect from the date of this announcement.

CHANGE OF COMPANY WEBSITE

The website of the Company will be changed to “www.longcorp.com” with effect from 24 December 2025 to reflect the Second Change of Company Name.
