On 29 April 2021, the Company redeemed all the outstanding convertible bonds in full at the redemption price equal to 100% of the outstanding principal amount of HK\$42 million together with all accrued and unpaid interest thereon. After the completion of the redemption, the convertible bonds were cancelled in whole and the Company was discharged from all of the obligations under and in respect of the said convertible bonds.
