(1) A total of 12,170,000 share options could be granted by the Company for the first grant of share options under the A Share Option Incentive Scheme as approved by the shareholders on 23 December 2020 (the “**Scheme**”). The date of first grant of share options under the Scheme is 21 January 2021. The Vesting Period of the Share Options granted to the Participants under the Scheme (i.e. the interval between the Date of Grant and the first Exercise Date) is 24 months, and the exercise of options is not allowed during the Vesting Period. This month falls within the Vesting Period of the Scheme.
