The closing balance of the Company's share capital as at 30 April 2025 comprised 206,594,736 H shares and 141,428,080 unlisted shares, amounting to a total of 348,022,816 issued shares. The Company has completed the H share full circulation on 14 May 2025 by converting 43,056,968 of its unlisted shares to H shares. Following the conversion and listing of the relevant converted H shares, the number of H shares increased by 43,056,968, while the number of unlisted shares decreased by 43,056,968. The total number of issued shares of the Company after the conversion and listing remains unchanged, comprising 249,651,704 H shares and 98,371,112 unlisted shares.
