Completion and return of the proxy form will not preclude a shareholder from attending and voting in person at the 2022 first class meeting of holders of unlisted foreign shares or any adjournment thereof if he/she so wishes. Shareholders and shareholder proxies are required to produce identity proof when attending the Class Meeting of Holders of Unlisted Foreign Shares (and any adjournment thereof).
