FURTHER DELAY IN DESPATCH OF CIRCULAR

Reference is made to (i) the announcement (the “**Announcement**”) of Siberian Mining Group Company Limited (the “**Company**”) dated 13 April 2017 in relation to, among other things, the extension of Maturity Date of the Outstanding Third Convertible Note; and (ii) the announcements of the Company dated 9 May 2017 (the “**First Delay Announcement**”) and 29 May 2017 (the “**Second Delay Announcement**”), respectively, in relation to the delays in despatch of a circular (the First Delay Announcement and the Second Delay Announcement, together with the Announcement, the “**Announcements**”).
