This announcement is made by InnoScience (Suzhou) Technology Holding Co., Ltd. (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 29 September 2025 (the “**Announcement**”) in relation to the proposed implementation of the H Shares Full Circulation by the Company. Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Announcement.

The Board of the Company is pleased to announce that the Company has received the filing notice dated 26 March 2026 issued by the CSRC for the H Shares Full Circulation (the “**Filing Notice**”). According to the Filing Notice, the filing has been completed with the CSRC in respect of the conversion of a total of 373,841,270 domestic unlisted shares held by 35 shareholders into H Shares and their listing and trading on the Main Board of the Stock Exchange by the Company. In case that the Conversion and Listing is not completed within 12 months from the date of issuance of the Filing Notice and the Company intends to continue to proceed with the same, the Company shall update the filing materials.
