**POLL RESULTS OF ANNUAL GENERAL MEETING ON

The Board is pleased to announce that at the AGM held on 25th August, 2014, all the Resolutions were duly passed by the shareholders of the Company attending and voting at the AGM either in person or by proxy or by their duly authorised representatives by way of poll.

The board of directors (the “Board”) of Midas International Holdings Limited (the “Company”) is pleased to announce that at the annual general meeting (the “AGM”) of the Company held on 25th August, 2014, all proposed resolutions (the “Resolutions”) were duly passed by the shareholders of the Company attending and voting at the AGM either in person or by proxy or by their duly authorised representatives by way of poll.

The full text of the Resolutions were set out in the notice of the AGM dated 22nd July, 2014.

As at the date of the AGM, the total number of issued shares of the Company was 2,207,208,278 which was the total number of shares entitling the shareholders to attend and vote on the Resolutions at the AGM. There were no shares entitling shareholders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in rule 13.40 of the Rule Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”) and no shares requiring shareholders under the Listing Rules to abstain from voting the Resolutions at the AGM. None of the shareholders has stated their intention in the Company’s circular dated 22nd July, 2014 to vote against or to abstain from voting on any of the Resolutions at the AGM.
