On January 28, 2026, the Company entered into the Placing Agreement with the Joint Placing Agents, BNP Paribas Securities (Asia) Limited and Guotai Junan Securities (Hong Kong) Limited. Completion of the Placing took place on February 4, 2026. An aggregate of 12,000,000 Placing Shares have been placed by the Joint Placing Agents to not less than six Placees at the Placing Price of HK\$32.46 per Placing Share, representing approximately 2.06% of the total number of Shares in issue as enlarged by the issue of the Placing Shares.
