As of 30 September 2018, (i) 258,738,552 shares of the issuer may be issued pursuant to the exercise of the share options granted pursuant to the issuer's pre-IPO employee stock incentive scheme; and (ii) 251,282,415 shares of the issuer may be issued pursuant to the vesting of the restricted share units granted pursuant to the issuer's pre-IPO employee stock incentive scheme.

729,848 Class B ordinary shares of Meituan Dianping were issued on 20 September 2018 pursuant to the issuer's pre-IPO employee stock incentive scheme. 762,198 restricted share units granted pursuant to the issuer's pre-IPO employee stock incentive scheme were cancelled during the month.
