UNAUDITED OPERATING STATISTICS FOR DECEMBER 2021

The board of directors (the “**Board**”) of Zhenro Properties Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that during the month ended 31 December 2021, the aggregate contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB10.011 billion with contracted gross floor area sold of approximately 595,972 square meters. The contracted average selling price for the month ended 31 December 2021 amounted to approximately RMB16,800 per square meter.

For the twelve months ended 31 December 2021, the aggregate contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB145.643 billion, the aggregate contracted gross floor area sold amounted to approximately 8,802,642 square meters and the contracted average selling price was approximately RMB16,500 per square meter.
