The abbreviation and code of the A Share Convertible Bonds are "China Galaxy Convertible Bonds" and 113057, respectively. The adjusted conversion price of the A Share Convertible Bonds is RMB9.93 per A Share (w.e.f 15 July 2022). The term of the A Share Convertible Bonds will be six years from the date of issuance, i.e. from 24 March 2022 to 23 March 2028. The conversion period of the A Share Convertible Bonds starts from 30 September 2022 and ends on 23 March 2028. The Company's A Share Convertible Bonds totalling RMB7.8 billion were listed and traded on Shanghai Stock Exchange on 10 May 2022.
