COMPLETION OF ISSUANCE OF 2025 TWENTY-FIRST TRANCHE
OF SHORT-TERM COMMERCIAL PAPER

Reference is made to the circular of China Galaxy Securities Co., Ltd. (the “**Company**”) dated 23 January 2025 and the announcement dated 17 February 2025.

The amendment to the plan on authorization given by the shareholders’ general meeting to the board of directors of the Company (the “**Board**”) was approved at the first extraordinary general meeting of 2025 of the Company held on 17 February 2025, pursuant to which, the Board has been authorized to issue debt financing instruments with the total issuance size not exceeding 350% of the latest audited net assets of the Company.

The Board is pleased to announce that in accordance with the above authorization, the Company has completed the issuance of 2025 twenty-first tranche of short-term commercial paper (the “**Commercial Paper**”) on 8 September 2025. The issue size of the Commercial Paper is RMB4 billion with the nominal value and the issue price of RMB100 per unit. The Commercial Paper has a term of 86 days and a final coupon rate of 1.60%. The proceeds from the issuance of the Commercial Paper will be used to supplement the working capital of the Company.
