The Board is pleased to announce that all the Resolutions were duly passed by the Shareholders by way of poll at the AGM held on 6 June 2016.

Reference is made to the notice (the “**Notice**”) of annual general meeting (the “**AGM**”) of AGTech Holdings Limited (the “**Company**”) dated 6 May 2016, and the circular of the Company dated 6 May 2016 (the “**Circular**”).
