POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 14 JUNE 2024

References are made to the notice (the “**AGM Notice**”) of the annual general meeting (the “**AGM**”) of Archosaur Games Inc. (the “**Company**”) and the circular (the “**Circular**”) of the Company, both dated 23 April 2024. Unless otherwise indicated, capitalised terms used herein have the same meanings as those defined in the Circular.

POLL RESULTS OF AGM

Pursuant to Rule 13.39(5) of the Listing Rules, the Board is pleased to announce that the resolutions proposed at the AGM (the “**Proposed Resolutions**”) as set out in the AGM Notice were duly passed by the Shareholders by way of poll at the AGM held on 14 June 2024.

As at the date of the AGM, the total number of issued Shares was 798,574,630 Shares. Smooth Ebony Limited held 16,405,200 Shares in relation to the share scheme(s) of the Company, representing approximately 2.05% of the issued share capital of the Company as at the date of the AGM, was required to abstain and did abstain from voting on all the resolutions proposed at the AGM. Accordingly, as at the date of the AGM, the total number of Shares entitling the Shareholders to attend and vote on the Proposed Resolutions at the AGM was 782,169,430. Save as disclosed above, (1) there were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Proposed Resolutions at the AGM in accordance with Rule 13.40 of the Listing Rules; (2) no Shareholder was required under the Listing Rules to abstain from voting on the Proposed Resolutions; and (3) none of the Shareholders had indicated in the Circular that they intended to vote against or to abstain from voting on any Proposed Resolutions at the AGM.

The Company’s Hong Kong share registrar, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking at the AGM.
