Pursuant to the sale and purchase agreement dated 24 August 2012 entered into between Mysteriously Time Investments Limited (a wholly-owned subsidiary of Chanceton Financial Group Limited (the “Company”)) and Refulgent Sunrise Limited (“Refulgent”), the Company may issue an aggregate of 75,000,000 new ordinary shares of the Company to Refulgent as consideration for the acquisition of 20% equity interests in Revenue Synthesis Limited (a wholly-owned subsidiary of Refulgent). On 8 May 2013, the Company completed a bonus issue on the basis of three bonus shares for every one existing share. Upon completion of the bonus issue, the abovementioned possible issuance of 75,000,000 new ordinary shares was adjusted to 300,000,000 new ordinary shares.
