The Board is pleased to disclose the unaudited mobile payment operational statistics for the month ended 31 May 2011.

The board (the “**Board**”) of directors (the “**Director(s)**”) of Sing Lee Software (Group) Limited (the “**Company**”) is pleased to disclose the mobile payment operational statistics of the Company and its subsidiaries (collectively the “**Group**”) for the month ended 31 May 2011.

The Mobile Payment business was officially launched by entering into a four-year strategic cooperation agreement between the Group and the Yunnan Branch of China UnionPay Co., Ltd on August 2010 and entering into a five-year strategic cooperation agreement between the Group and the China UnionPay Co., Ltd (“**China UnionPay**”) on October 2010. The business are at the early stage in China’s Mobile E-commerce. The two core parts of the Mobile Payment business are as follow:

- (1) The increase in number of mobile payment customers, especially the increase in number of active customers
- (2) The growing in volume of transactions. With the continued introduction of mobile payment products, the Group had worked closely with China UnionPay. The preparation work in various aspects was preliminarily completed at December 2010 and put into the market in 2011.
