THE DISPOSAL

The Board is pleased to announce that on 29 March 2019, the Vendor and the Purchaser entered into the Agreement, pursuant to which, the Vendor has conditionally agreed to sell and the Purchaser has conditionally agreed to acquire, the Sale Shares at the consideration of approximately HK\$1.74 million shall be paid by the Purchaser to the Vendor.

Upon Completion, the Target Company becomes an associate of the Company.

INTRODUCTION

The Board is pleased to announce that on 29 March 2019, the Vendor and the Purchaser entered into the Agreement, pursuant to which, the Vendor has conditionally agreed to sell and the Purchaser has conditionally agreed to acquire, the Sale Shares at the consideration of approximately HK\$1.74 million shall be paid by the Purchaser to the Vendor. The Sale Shares represents 60% of the issued share capital of the Target Company.

THE AGREEMENT

Parties: (i) the Vendor; and
(ii) the Purchaser

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Purchaser is a third party independent of each of the Company and their respective connected persons.

Assets to be disposed

Pursuant to the Agreement, the Vendor has conditionally agree to sell and the Purchaser has conditionally agreed to purchase the Sale Shares.

As at the date of this announcement, the Vendor is the legal and beneficial owner of the Sale Shares.

Upon completion, the Target Company will become an associate of the Company.

Consideration

The consideration of approximately HK\$1.74 million shall be paid by the Purchaser to the Vendor in the following manners:

1. 1st instalment of HK\$0.50 million will be paid on or before 15 April 2019;
2. 2nd instalment of HK\$0.50 million will be paid on or before 5 June 2019;
3. 3rd instalment of HK\$0.50 million will be paid on or before 5 August 2019; and
4. the remaining balance of approximately HK\$0.24 million on or before 5 September 2019.

The Consideration has been arrived at arm's length negotiations between the Vendor and the Purchaser with reference to, including but not limited to, (i) the net assets of the Target Company as at 30 November 2018; (ii) the Target Company's loss making position; and (iii) the stock value of the Target Company as to Cut-off Date.

Conditions precedent

Completion is subject to the following conditions being fulfilled or waived (as the case may be):

- (i) the board of directors and shareholders of the Vendor approving the Agreement and implementation of the transactions contemplated by the Agreement;
- (ii) the completion of the due diligence by the Purchaser and the resolution of the issues arising from the due diligence by the Vendor and the Company in manner satisfactory to the Purchaser, acting reasonably; and
- (iii) none of the warranties made by the Vendor under, and other provisions of this Agreement having been breached in any material respect (or, if capable of being remedied, has not been remedied), or (in respect of any of the aforesaid warranties) is misleading or untrue in any material respect.

The Conditions are solely for the Purchaser's benefit and the Purchaser may at its sole discretion waive any of the Conditions at any time by notice in writing to the Vendor. The Vendor shall use best endeavours to procure the fulfilment of the Conditions as soon as possible after the date of this Agreement.

Completion shall take place on the Completion Date after all the conditions of the Agreement have been fulfilled or waived or such date as the Vendor and the Purchaser may agree in writing.

Upon Completion, the Target Company will become an associate of the Company.

INFORMATION ON THE VENDOR AND THE TARGET COMPANY

The Vendor is a company incorporated in British Virgin Islands with limited liability and is an investment holding company.

The Target Company is a company incorporated in Hong Kong with limited liability, which is a subsidiary of the Vendor. The Target Company is principally engaged in the wholesale business in Hong Kong.

FINANCIAL INFORMATION OF THE TARGET COMPANY

Set out below is a summary of the key financial data of the Target Company extracted from its audited financial statements for the year ended 31 March 2017 and 31 March 2018:

As at 30 November 2018, the unaudited net assets of the Target Company amounted to approximately HK\$3.5 million.

INFORMATION OF THE PURCHASER

The Purchaser is a merchant. To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Purchaser is a third party independent of the Company and its connected persons.

REASONS FOR AND BENEFITS OF THE DISPOSAL

The Group is principally engaged in money lending business, financial instruments and quoted shares investment, retail and wholesale business in Hong Kong.

Looking at the Group's historical performance of wholesale business in Hong Kong, the Board is of the view that the wholesale business in Hong Kong is not performing as expected and to continue the wholesale business is going to take up too much resources of the Group which can be put on other more promising sectors. As such, the Board considers that by disposing the Target Company, the Group can re-focus its resources to other more profitable business sectors of the Group.

The Directors consider that the terms of the Agreement (including the Consideration) and the transactions contemplated thereunder are on normal commercial terms, fair and reasonable and in the interests of the Group and the Shareholders as a whole.

FINANCIAL EFFECT OF THE DISPOSAL

Immediately after completion of the Disposal, the Target Company will become an associate of the Company and the financial results of the Target Company will classify by the Group as an investment in associate accounted for using the equity method.

It is expected that the Group will recognize a loss in its consolidated income statement of approximately HK\$326,000 upon completion of the Disposal. Subject to audit, the actual amount of gain or loss on Disposal to be recognized by the Group will be based on the actual net asset value of the Target Company as at Completion and therefore may vary from the amount mentioned above.

The intended sales proceeds (after deducting relevant costs and expenses in connection with the Disposal) will be applied to the general working capital of the Company.
