FURTHER INFORMATION ON WINDING-UP PETITION

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of hmvod Limited (the “**Company**”) pursuant to Rule 17.10(2)(a) and Rule 17.27(1)(b) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 20 June 2025, 29 July 2025, 5 August 2025, 7 August 2025, 20 August 2025, 25 August 2025, 5 September 2025 and 22 September 2025 in relation to the winding-up petition filed against the Company at the High Court of the Hong Kong Special Administrative Region (the “**Announcements**”). Unless otherwise specified, capitalised terms used herein shall have the same meaning as those defined in the Announcements.

As disclosed in the announcement of the Company dated 22 September 2025, at the hearing of the High Court on 22 September 2025, the High Court ordered that the hearing of the Petition be adjourned to the first Monday following the determination of the Company’s appeal, on the condition that the Company pay the balance of the Judgment Sum in the amount of HK\$9,456,336 into court within 21 days from the date of the order (the “**Order**”).

The Board hereby announces that the Company has duly complied with the Order by paying HK\$9,456,336 into court on 13 October 2025, which was funded by way of shareholder loans provided to the Company. The filing of the Petition or the Order does not represent the successful winding-up of the Company by the Petitioner. No winding-up order has been granted by the High Court to wind up the Company as at the date of this announcement. The Company is currently awaiting the outcome of its appeal, and the hearing of the Petition will be adjourned to the first Monday following the determination of the Company’s appeal.

The Company will keep its shareholders and investors informed of any significant development and further announcement will be made by the Company as and when appropriate.

Shareholders and potential investors of the Company should exercise caution when dealing in the securities of the Company.
