An ordinary resolution was passed at the extraordinary general meeting of the Company held on 29 March 2017 in which the amendments to the terms of the convertible bonds due 2017 (the “Convertible Bonds”) with effect from 18 January 2017. The maturity date of the Convertible Bonds was extended for six months from 17 January 2017 to 17 July 2017, and further extended maturity date upon a prior written consent from the Bondholder shall be 17 January 2018. The conversion price of Convertible Bonds is amended from HK\$0.598 per share to HK\$0.359 per share, which can be converted into for the maximum number of 249,651,810 shares. For details, please refer to the announcement dated 18 January 2017.
