DISCLOSEABLE TRANSACTION IN RELATION TO THE ENTERING INTO TENANCY AGREEMENT

The Board announces that on 17 April 2026, Well Being Dental, an indirect subsidiary of the Company, as tenant and Landlord entered into the Tenancy Agreement in respect of the lease of the Premises at the monthly rent of HK\$107,954.00 (exclusive of rates, service and management charges and other outgoings) for a term of three (3) years commencing on 1 May 2026 and expiring on 30 April 2029, both days inclusive.

LISTING RULES IMPLICATIONS

In accordance with HKFRS 16 “Leases”, the entering into of the Tenancy Agreement will require the Group to recognise the lease of Premises as the right-of-use assets on its balance sheet, thus the entering into of the Tenancy Agreement and the transaction contemplated thereunder will be regarded as an acquisition of asset by the Group under the GEM Listing Rules. The unaudited value of the right-of-use asset recognised by the Company under the Tenancy Agreement amounted to approximately HK\$3.5 million.

As one or more of the applicable percentage ratio under Rule 19.07 of the GEM Listing Rules in respect of the value of the right-of-use assets recognised by the Group pursuant to HKFRS 16 is more than 5% but less than 25%, the entering into of the Tenancy Agreement and the transaction contemplated thereunder constitute a discloseable transaction for the Company, and is subject to the reporting and announcement requirements under the Chapter 19 of the GEM Listing Rules.

(I) THE TENANCY AGREEMENT

The Board announces that on 17 April 2026, Well Being Dental, an indirect subsidiary of the Company, as tenant and Landlord entered into the Tenancy Agreement in respect of the lease of the Premises.

The principal terms of the Tenancy Agreement are summarised below:

The right-of-use asset

The unaudited value of the right-of-use asset recognised by the Company under the Tenancy Agreement amounted to approximately HK\$3.5 million which is calculated with reference to the aggregate lease payment and discounted by a discounted rate.

Reasons for and benefits of the entering into of the Tenancy Agreement

The Premises is used for the operation of dental services centre, which are core dental services rendered by the Group. The Directors consider that The World Trade Centre is one of the major commercial hubs in Hong Kong. The opening of dental services centre in The World Trade Centre not only gives positive impact on the Group's reputation and marketing position but also helps to attract more patients to visit the Group's dental services centre.

The terms of the Tenancy Agreement were determined after arm's length negotiation between the Landlord and the Group and the rent was determined with reference to the open market rental of properties of comparable size, location, facilities and usage. The Directors considered that the terms of the Tenancy Agreement are fair and reasonable and the transaction is on normal commercial terms, in the ordinary and usual course of business of the Group and in the interests of the Company and the shareholders as a whole.
