LITIGATION

Reference is made to the announcement of L & A International Holdings Limited (the “**Company**”) dated 28 November 2016 and 6, 12, 23 and 28 December 2016, and 3 and 10 February 2017, and 21 December 2017 in respect of various writs of summons issued against the Company and its various directors by plaintiffs Kim Sungho, Lim Hang Young, Lee Moonkyu, and Joung Jong Hyun, respectively.

On 11 April 2018, the actions:

- HCA 3159 of 2016 commenced by the plaintiff Kim Sungho against the Company;
- HCA 3164 of 2016 commenced by the plaintiff Joung Jong Hyun against the Company and directors Mr. Ng Ka Ho (“**Mr. Ng**”) and Mr. Ma Chi Ming (“**Mr. Ma**”);
- HCA 3173 of 2016 commenced by the plaintiff Lee Moonkyu against the Company, and directors Mr. Ng and Mr. Ma; and
- HCA 3191 of 2016 commenced by the plaintiff Lim Hang Young against the Company, and directors Mr. Ng and Mr. Ma,

were dismissed by the Court on the ground that the respective Statement of Claim in each case disclosed no reasonable cause of action, were scandalous, frivolous or vexatious, may prejudice, embarrass or delay the fair trial of the proceedings, and/or they were otherwise an abuse of the process of the Court. The Plaintiffs in the respective cases were ordered to pay costs to the Company, Mr. Ng, and Mr. Ma.
